Dr. Hamilton continues to lend insight to national development and advocacy through his leadership engagement in local civil society organizations. His professional experience in Business Management and Human Resources Management was honed while working as an Office Administrator / Comptroller in The Bahamian Co-operative Industry and as a Management Consultant for a varied selection of private companies.

A Justice of the Peace for The Commonwealth of The Bahamas, Dr. Hamilton holds a Doctorate in Theology, Masters of Theology, Bachelors of Theology from Christian Life School of Theology (Columbus Georgia - USA); an Associate of Arts in Business Administration from The College of The Bahamas, a Business Diploma from the University of Wisconsin Graduate School and a Trade Union Education Diploma from the University of The West Indies / Trade Union Congress Bahamas.
